**Additional information: Tourist tax** In Greece, a tourist tax has been levied since 2018 according to a recent decision by the Greek government. The tax will be charged by hoteliers upon guest arrival or departure. The tourist tax depends on the classification (country category) of the hotel.

For 1\* and 2\* hotels/accommodations, the tax is approximately EUR 0.50 per room per night.

For 3\* hotels/accommodations, the tax is approximately EUR 1.50 per room per night.

For 4\* hotels/accommodations, the tax is approximately EUR 3 per room per night.
